"We have asked the actress to be present at Bandra police station to give her statement in connection with the probe into Rajput's suicide," said Abhishek Trimukhe, DCP (Zone 9). Commenting

on whether a police team will be sent to Manali in accordance with the actress' request, Trimukhe said the police had not considered the request yet. A police officer said that the decision to summon Ranaut was deemed necessary after she claimed in several media statements that she had proof that Rajput was pushed to depression, leading to suicide on June 14. While police had earlier tried to summon Ranaut to record her statement, there

was no response, the officer said. Sources said that a forensic analysis report of the actor's viscera had been submitted to the police by the regional forensic science laboratory at Kalina in Mumbai.
